Since calling at the Scottish Bar, James has developed a busy practice both in the Court of Session and at inquiry whilst maintaining his English practice. He has recommendations in the Scottish Bar for both Planning, Environmental and Licensing and the Civil Liberties, human rights, public inquiries and public and administrative law in the latest edition of Legal 500 (2019) and in the Planning & Environment, Real Estate Litigation and Administrative & Public law sections of Chambers UK (2019). He also undertakes a broad range of commercial work, recently having completed a number of high value compensation cases in the Lands Tribunal and acted for Disclosure Scotland in a lengthy commercial court proof. Biography

Planning and environment

James acts for a large number of both private and public clients at inquiry and in the courts. He has appeared in the Supreme Court for Dundee City Council in *Tesco v Dundee* when it successfully resisted Tesco's appeal. He acted for Mrs Uprichard in March 2013 on her ultimately unsuccessful appeal against the decision of the Inner House dismissing her challenge to the Fife Structure Plan, but for which she obtained a Protective Expenses Order. He most recently appeared in *Trump v Scottish Ministers* for Trump. Most recently he obtained permission to appeal to the Supreme Court in the

Elsick challenge but did not subsequently appear.

Private client

Retail: He has advised on or acted in several "supermarket battles" for landowners and/or developers including for the Co-Op over a site in Glasgow. He acted for British Land in an Inquiry concerning Fort Kinnaird and recently obtained permission for retail development adjacent to Inshes roundabout in Inverness.

Housing: He represented a number of housing developers successfully resisting a challenge to the Cairngorms National Park Local Plan in both the Inner and Outer Houses. He has also acted for and advised many other private clients including Hallam Land, Grahams Dairies and the Lamberkin Trust in respect of major housing developments in central Scotland. He appeared for the Lamberkin Trust to resist a challenge to the refusal of a permission for a rival developer - Pilkington Trust v Scottish Ministers and is advising various landowners in South Lanarkshire and elsewhere to secure major housing developments.

Windfarms & quarries: He acted for Fauch Hill in their s.36 application in West Lothian and recently for Cemex at the second inquiry into their promotion of an expansion of their quarry close to the New Lanark World Heritage Site (outcome awaited). He acted for Cemex at the first inquiry and in the appeal which led to the negative result being quashed by consent. Recently he acted for Ecotricity in Perthshire seeking a s.36 consent at Dulater and likewise in Argyll at Upper Sonachan. He acted for third party groups in respect of fresh applications at Dorenell and Fallago Rig and challenged the decision in respect of Craig Rhiabac.

CPO: He is currently advising a number of clients on a wide variety of CPO matters, including Electricity Act claims, and appeared in the Lands Tribunal relating to compensation claim arising from the Edinburgh tram works and two cases concerning wind turbines. Related to one of those claims, he acted for Auquhirie Land Company in the Inner House, successfully resisting an appeal against a decision in their favour by the Lands Tribunal. Most recently he has acted for an objector to the A96 Inverness to Nairn dualling CPO inquiry.

Environment: He acted for the RSPB in their recent challenges concerning offshore windfarms, and he acted for Dawnfresh in the Court of Session seeking to uphold their permission for a new fish farm in Loch Etive. He appeared in the appeal by Bova and Christie in the Inner House which raised procedural issues concerning delay in challenges and flooding. He acted for Mr Gibson in his appeal in the Inner House against a refusal for a PEO. He is currently acting in several judicial reviews and planning appeals before the Court of Session.

Local planning authorities

Wind farms: He has appeared for Highland Council at many inquiries resisting wind farms in Caithness and elsewhere, most recently being successful at Cnoc an Eas, Culachy, Druim Ba, Caplich and West Garty. He has advised in respect of several other inquiries which did not go to a hearing or inquiry, including Daviot. He is awaiting the result of three further inquiries. He acted for PKC in the Tullymurdoch and Banff and Crossburns windfarm appeals and for Cairngorms National Park Authority at Dorenell. He acted for Angus Council resisting two turbines in Montrose. He also advised a number of other authorities on wind and mining issues, including East Ayrshire. He has also appeared for SNH, sometimes jointly with Highland Council, and is due to appear for them and South Lanarkshire Council at an inquiry in early 2019.

Quarries and waste: He appeared for Highland Council in respect of a proposed quarry near Muir of Ord and at the WTE application at Invergordon and has appeared at a further WTE inquiry for PKC (appeal dismissed).

Historic Buildings: He is acting for East Ayrshire Council in the Loudoun inquiry, which concerns the extent of enabling development to stabilise a ruined castle. Outcome awaited.

General local government

He has considerable general local government expertise in nearly all areas of such work.

In local government matters he has successfully appeared in the Outer House for Clackmannanshire

Council resisting a claim for damages by Sidey Limited following a flawed procurement exercise. He appeared as Junior Counsel with James Mure Q.C. in the Inner House and Supreme Court in an appeal on the interpretation of an option in a lease - *Multilink v North Lanarkshire Council* - successfully on both occasions. He appeared with Roy Martin Q.C in *Portobello Park Residents* appeal to the Inner House concerning the Council's attempt to appropriate inalienable common good land and more recently in *East Renfrewshire Petitioner*. In terms of advice work, James has advised on numerous other planning matters, including the impact of a SPA on peat extraction permissions, various supermarket matters and other similar issues.

Licensing

Amongst various licensing matters he appeared throughout for BP, led by Sir Menzies Campbell Q.C., in its appeals relating to the sale of alcohol in shops on garage forecourts. He also subsequently acted for BP against Falkirk and recently succeeded in a challenge against Stirling's licensing board. He represented Corinthian Clubs in the review of their casino premises licence and is currently acting for MAB bookmakers in their appeal against a refusal of a betting office in Orkney.

Commercial

He acted for Disclosure Scotland in a £5M plus breach of contract claim which settled during proof and is acting for North Lanarkshire Council on a similar claim. He has recently advised in a contentious cross border dispute between three professional bodies.
